

## Commercial/Industrial Vacant Unit Tax Rebate Program By-Law Number 2017- 210

Pending Ministry approval the City of Belleville's Vacant Unit Rebate Program will be phased-out over 2 years. The City will be accepting applications for the 2017 and 2018 taxation years only. The program will be eliminated effective for the 2019 taxation year.

Council has approved the following changes for the Vacant Unit Rebate Program for the 2017 & 2018 Taxation Years as part of their review of the program:

- 2017 Applications: The Industrial rebate will be reduced to 30% from 35%
- 2018 Applications: The Industrial and Commercial rebates will be reduced to 15%
- The eligibility criteria for the 2017 and 2018 applications include:
  - 1. capable of being leased for immediate occupation;
  - 2. properties must be in full compliance with the City's property standards;
  - 3. must provide a marketing plan for the vacant portion of the property.

The City of Belleville offers Commercial and Industrial property owners rebates on taxes for all or portions of their properties that have been vacant during the year. The following are the program details.

#### **Application Instructions:**

Only two applications can be submitted per year per property. Interim applications must be received by July 31st.

Final applications must be received by the last day of February of the year following the taxation year to which the application relates.

- Application may be submitted by the owner or by a person representing the owner.
- Applications may be subject to an onsite audit and inspection.
- Any person who knowingly makes a false or deceptive statement in this application is guilty of an offence and, upon conviction, is liable for a fine.
- To be eligible for a rebate, a building or portion of a building must satisfy the conditions described in the eligibility criteria.
- The application must be completed and all required information provided. The onus is on the applicant to provide documentation to support their vacancy rebate application. Failure to provide the above documentation may result in the rejection of the rebate application.

# APPLICATION FOR PROPERTY TAX REBATE – ELIGIBILITY

To be eligible for a rebate, a building or portion of a building must satisfy the conditions as described below.

Please check or select to confirm eligibility;

## **Buildings that are Entirely Vacant (Commercial or Industrial)**

#### Commercial

A suite or unit within a commercial building will be eligible for a rebate if, for at last 90 consecutive days, it was:

- Unused; and
- Clearly delineated or physically separated from the used portions of the building; and
- Either
  - Capable of being leased for immediate occupation
  - Properties must be in full compliance with the City's property standard

#### Industrial

A portion of an industrial building will be eligible for a rebate, if at least 90 consecutive days, it was:

- Unused; and
- Clearly delineated or physically separated from the used portion of the building.

#### **Exclusions**

**Seasonal Property:** Businesses that operate on a seasonal basis are not eligible for a rebate for the seasons that they are closed.

**Leased property:** Buildings or portions of buildings that are vacant, but are leased to a tenant, are not eligible for a rebate.

**Vacant Land Sub-Class:** Buildings that are included in a vacant land sub-class, (ie: new buildings that have never been occupied) are not eligible for a rebate.

Taxes on property assessed as a residential or multi-residential are NOT applicable.

If a property owner receives a notice of omitted assessment from the Municipal Property Assessment Corporation (MPAC), after a tax year, the deadline to submit an application for a rebate is 90 days after the date of issuance of the notice of omitted assessment.

## **Processing of Applications**

## Applications will be processed through the following steps:

- 1. Property owner or authorized representative submits an application to the local Municipality.
- 2. Municipality forwards a copy of the application to MPAC.
- MPAC determines the assessed value that is attributable to the vacant area.
- 4. MPAC notified the municipality of the value of the eligible vacant property.
- 5. Municipality will calculate the rebate and notify the property owner. Rebates may be issued as a credit against an outstanding tax liability or through direct payment to the property owner.
