City of Belleville Committee of Adjustment

Due to the ongoing COVID-19 situation, the City of Belleville is now conducting all committee meetings virtually. Members of the public will still have the ability to provide input and watch meeting proceedings digitally.

A Public Meeting, as noted above, will be held on August 19, 2021 at 3:30 P.M. to consider an application under Section 53 of the Planning Act submitted by Keith Watson of Watson Land Surveyors on behalf on Marcus Sullivan.

The subject property is municipally known as 149 Denyes Road, and is zoned PA – Prime Agriculture Zone, RU – Rural Zone, and H – Hazard Zone in By-Law 3014. The application proposes to create one (1) new residential lot with a lot frontage of 205 metres on Highway 37 and a lot area of 2.4 hectares.

A Location Plan is shown on APPENDIX 1, attached.

As per the requirements of the Planning Act, this application is confirmed to be complete. Those who have registered will be provided with the Zoom meeting information prior to the meeting date. Registration will close at 4 p.m. Tuesday, August 17, 2021.

To participate in a meeting via telephone, members of the public must register by calling 613-967-3242 and leaving a message with their name, phone number and the agenda item(s) they wish to speak to; City staff will then contact the member of the public to confirm their participation and provide meeting details. Registration will close at 4 p.m. Tuesday, August 17, 2021.

How to ask a question during the meeting:

Registered members of the public will be able to provide comments and ask questions during virtual public meetings in a similar manner as in-person public meetings. The Chair of the meeting will announce each registered member when it is their turn to speak. Each registered member will be allocated five (5) minutes to provide comments and/or questions regarding the application.

Any person may attend this meeting and/or make written or verbal representation either in support of or in opposition to this application using methods explained above, or you may be represented by counsel for that purpose.

How to be notified of the decision:



submission to the City of Belleville Committee of Adjustment before it gives or refuses to give a provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.
