**Due to the ongoing COVID-19 situation, the City of Belleville is now conducting all committee meetings virtually. Members of the public will still have the ability to provide input and watch meeting proceedings digitally.**

**A Public Meeting, as noted above, will be held on July 15, 2021 at 3:30 P.M. to consider an application under Section 45 of the Planning Act submitted by David Barnard & Natalia Garavito on behalf of Sunil Kapahi & Sanjay Jangal of 11709097 Canada Inc.**

The subject property is municipally known as 100 Hannifin Road and is zoned CH-9/MS – Highway Commercial and Special Industrial Zone in By-Law 2076-80. The application requests relief to reduce the required number of parking spaces from 267 to 165 to facilitate the development of a warehousing facility. The proposed development proposes 39 parking additional parking spaces that cannot be officially counted, as they are in close proximity to Highway 401 and could be lost in the event of future highway improvements.

A Location Plan is shown on APPENDIX 1, attached.

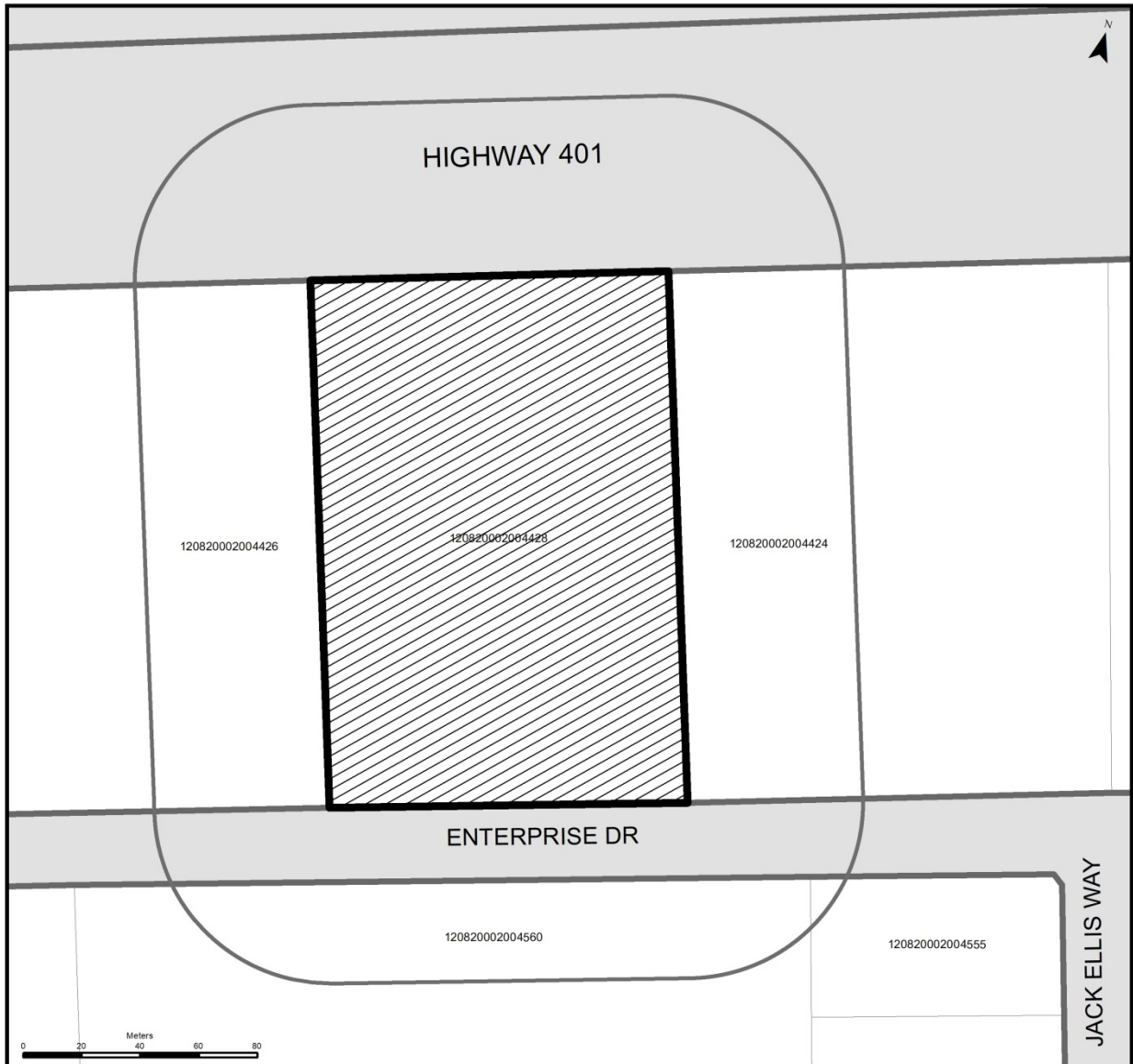
