**A Public Meeting, as noted above, will be held on November 19, 2020 at 3:30 P.M. to consider an application under Section 53 of the Planning Act submitted by Ruth Ferguson Aulhouse of RFA Planning Consultants Inc. on behalf of Adrian Bax.**

The subject property is municipally known as Part 10 of Plan 21R-18102, Part of Lot 2, Concession 4, Sunningdale Drive and is zoned PA – Prime Agriculture Zone in Zoning By-Law 3014. The application proposes to sever a residential lot located on the southeast side of the property with a lot area of 1.3 hectares and frontage of 74.0 metres.

A Location Plan is shown on APPENDIX 1, attached.

As per the requirements of the Planning Act, this application is confirmed to be complete. #### **Telephone**

### **How to ask a question during the meeting:**

Registered members of the public will be able to provide comments and ask questions during virtual public meetings in a similar manner as in-person public meetings. The Chair of the meeting will announce each registered member when it is their turn to speak. Each registered member will be allocated five (5) minutes to provide comments and/or questions regarding the application.

Any person may attend this meeting and/or make written or verbal representation either in support of or in opposition to this application using methods explained above, or you may be represented by counsel for that purpose.

### **How to be notified of the decision:**

If you wish to be notified of the decision of the City of Belleville Committee of Adjustment in respect of this application, you must submit a **written** request by emailing [planning@belleville.ca](mailto:planning@belleville.ca) or in writing to the Secretary-Treasurer of the Committee of Adjustment by mail at: Belleville City Hall, 169 Front Street, Belleville, K8N 2Y8.

If a person or public body that files an appeal of a decision of the City of Belleville Committee of Adjustment in respect of the proposed consent does not make a written submission to the City of Belleville Committee of Adjustment before it gives or refuses to give a provisional consent, the Local Planning Appeal Tribunal may dismiss the appeal.

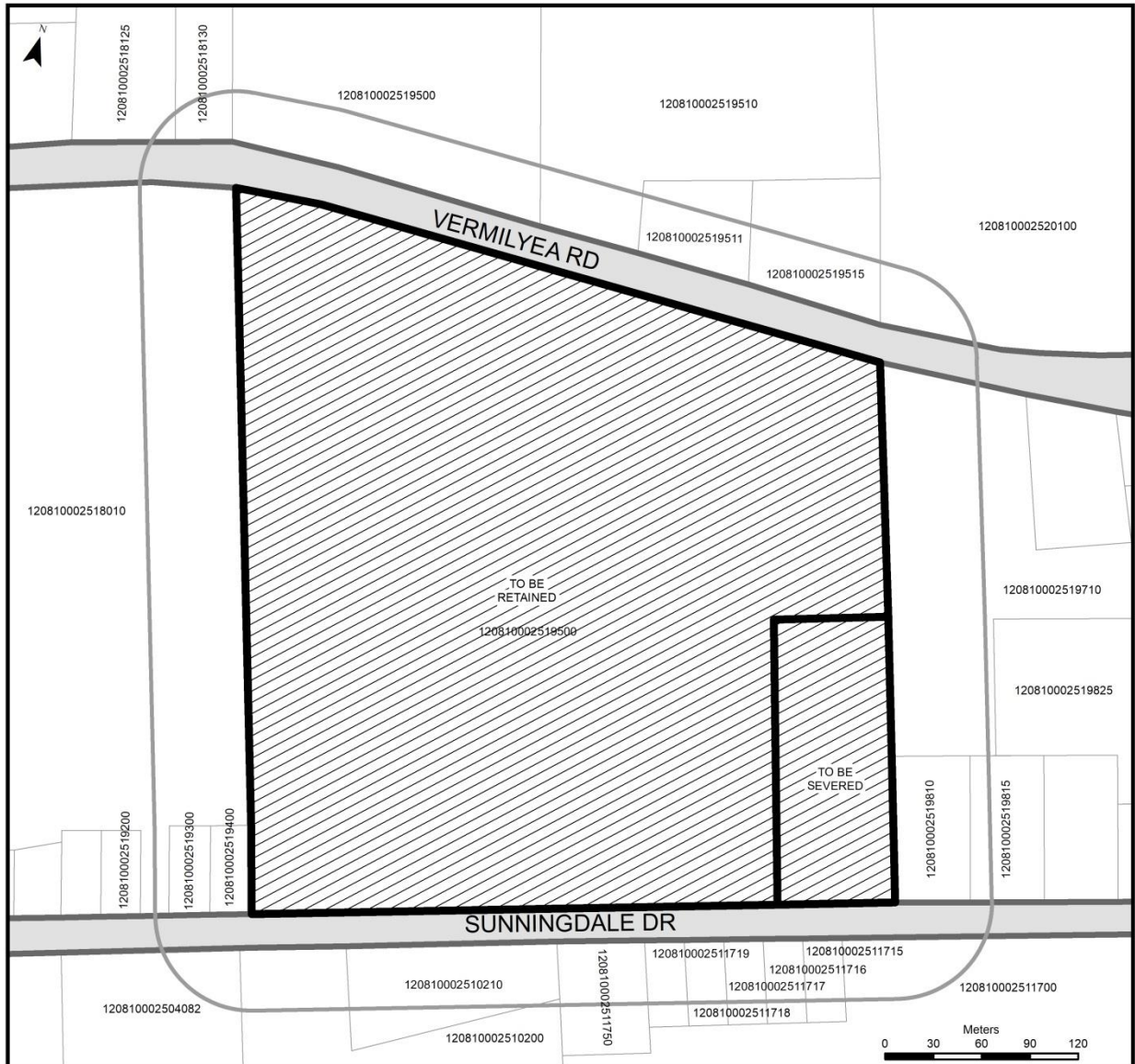
