**A Public Meeting, as noted above, will be held on February 16<sup>th</sup>, 2023 at 3:30 P.M. to consider an application under Section 53 of the Planning Act submitted by Justin Bell.**

Applications B 26/22 and B 27/22 propose to create two (2) new residential lots. Application B 26/22 proposes a residential lot with approximately 50 metres of frontage on Foxtan Road and 0.46 hectares of lot area. Application B 27/22 proposes a residential lot with approximately 45 metres of frontage on Boundary Road and 0.44 hectares of lot area.

A Location Plan is shown on APPENDIX 1, attached.

As per the requirements of the Planning Act, these applications are confirmed to be complete. Each member of the public wishing to speak will be allocated up to five (5) minutes in which to provide comments and/or questions regarding the application.

Any person may attend this meeting and/or make written or verbal representation either in support of or in opposition to this application using methods explained above, or you may be represented by counsel for that purpose.

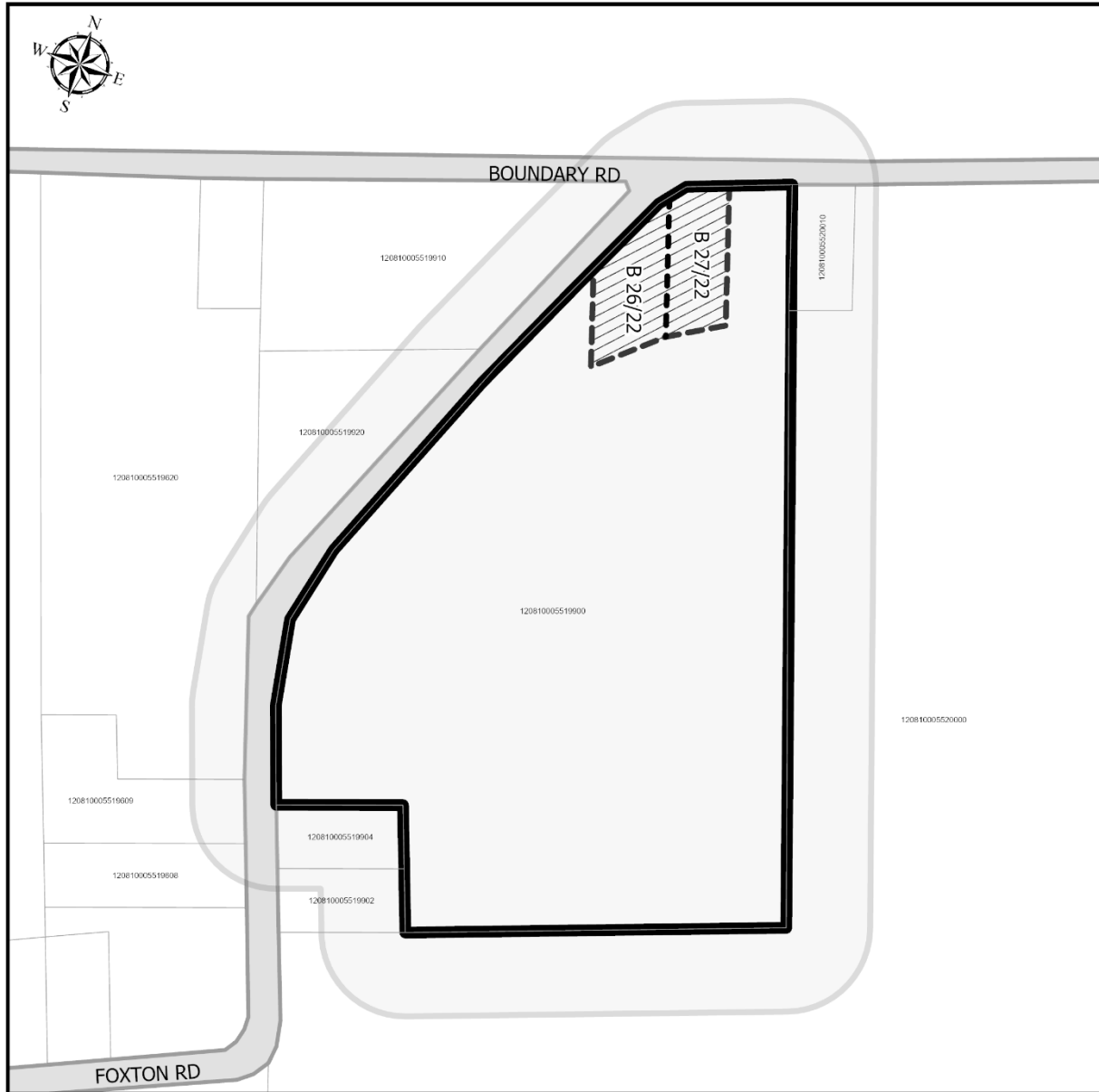
